# Updated special education model policies and procedures

The Ohio Department of Education and Workforce (ODEW) updated the special education model policies and procedures to include changes to the Operating Standards for the Education of Children with Disabilities, which are now available on the ODEW's Operating Standards and Guidance webpage. All educational agencies must upload verification of local school board approval of policies and procedures for the 2024-2025 school year though the Monitoring System by March 30, 2025. Beginning with the 2025-26 school year, the annual due date is Nov. 30.

# **Compliance Refresher**

Retained Applicant Fingerprint Database (Rapback) Enrollment Timeline for Non-Licensed Employees and Contractors ORC 3319.316

Who is required to be enrolled in Rapback? Ohio educators and school bus drivers submit fingerprints through the BCI background check process as a condition of their initial employment or licensure.

Effective October 24, 2024, this program was expanded and includes non-licensed school employees and contractors if they have routine interaction with a student or regular responsibility for the care, custody, and control of a student. The school or district must determine the level of student interaction for a given position; however the following positions are commonly included: food service personnel, custodians, building secretaries or administrators, and other contractors and employees who interact with students. Those **not required** to be enrolled would typically include: volunteers (including parent volunteers) and contractors/employees who do not interact with students.

**Deadline:** Those non-licensed school personnel that are required to be enrolled in Rapback should be enrolled by **January 31, 2025**. The Rapback expansion and FAQs can be found <a href="here">here</a>.

Community schools are not exempt from the requirements for criminal records checks of job applicants as set forth in Ohio Revised Code sections 3319.39, 3319.391, and 3319.393.

How we verify compliance:

- 1. Schools' contracts, as a responsibility of the governing authority, include compliance with the code sections noted above.
- 2. Schools must submit an affidavit of compliance with the requirements for background checks when there are additions to the staff roster (including contractors) or governing authority members. Updated rosters and affidavits are requested three times each school year as an Epicenter submission.
