FOREWORD

Much has changed in education in Dayton during the past two years. The remarkable election of a "reform" majority to the Dayton school board, and the selection of a new superintendent. Passage of a huge levy for school-building construction and renewal. The arrival of the federal No Child Left Behind act and Ohio's Senate Bill 1. The dramatic growth of the charter-school sector—and of controversy surrounding it. Some ferment on the high-school reform front. And much more.

To us at the Thomas B. Fordham Foundation, it felt like time once again to "take the community's temperature" with respect to a wide array of K-12 education issues.

This is the fourth time we have underwritten and helped to organize such surveys—always with the help of the estimable Dayton-based firm, Paragon Alliance.

In 1998, we published *Education Reform in the Dayton Area: Public Attitudes and Opinions*. (You can find it on-line at http://www.edexcellence.net/foundation/publication/publication.cfm?id=49) In 1999-2000, we sponsored a survey of parents of children enrolled in Dayton's then-new charter schools. And in 2001 we published *Dayton Education in 2001: The Views of Citizens and Parents*. (You can locate it at http://www.edexcellence.net/foundation/publication/index.cfm?topic_id=6#6).

Why conduct such surveys? As we said in introducing the first of these, five years back, education increasingly finds itself at the top of America's domestic policy agenda. Politicians of all stripes talk constantly about improving the schools and boosting student achievement. But how best to do this? It's our view that important decisions about such vital issues ought not be shaped entirely by the enthusiasms of politicians and the demands of education's countless interest groups. It's vital that the public—parents, especially, but also voters, taxpayers and the "man and woman in the street"—be heard, too. Accordingly, we set out to provide Dayton (and Ohio) policymakers with reliable information about the concerns that the consumers of education hold and the reform ideas that they favor. In a successful democracy, it is essential that policymakers not be estranged from the citizens they represent.

This year, we once again enlisted Paragon's services and outstanding work was done—prompt, professional, responsive—by Susan McLaughlin, Kristen Van Wert and their team at Paragon. Their telephone survey was conducted from July to October 2003.

We asked the survey team to focus on four groups of parents: within Dayton, parents of children attending public, private and charter schools; and suburban public-school parents. Parents are not the only "consumers" of education whose views matter but they are surely the most fully engaged.

As you will see in the "highlights" that follow this introduction, and in the full Paragon report and technical notes that follow them, Dayton-area parents present a fascinating array of opinions and judgments, both about today's schools (and those who are responsible for them) and about changes

that could be made tomorrow. There is some evidence of improvement over the past couple of years—and much evidence of the distance yet to go.

Surveys have their limits, to be sure. Sometimes it's difficult to find willing respondents who comprise a solid statistical sample. But this one is respectable, very similar to 1998 and 2001. The technical notes explain the statistical robustness of the data presented here, data that, in our judgment, offer many lessons and tantalizing clues that are timely and relevant to education decisions that community (and state and federal) leaders face today.

I commend these findings to your attention and reflection. I would also like to thank Fordham's terrific program director, Terry Ryan, who recently moved himself and his family to Dayton to be better positioned to work (24/7 as far as I can tell) on behalf of improving education for the community's children. In partnership with the Paragon team, he did all the heavy lifting on this project.


I. Daytonians Embrace School Choice

Dayton parents have been living with school choice since 1997 and strongly support it in many forms.


Over 70% would allow students in failing schools to attend another school of their choice.

Q20. Do you support or oppose allowing students in a poorly-performing school to attend another school of their choice?




Most urban parents favor government paying the tuition so families can choose non-public schools (the proposal commonly known as "vouchers"). Among private-school parents, this rises to 72%; among charter-school parents to 81%.

Dayton parents are more receptive to vouchers than are Americans in general. This chart compares their views with those of respondents on the 2003 Phi Delta Kappa/Gallup survey.

Attending a private school at public expense...




Except in the suburbs, most Dayton-area parents (and two-thirds of charter parents) would allow students to choose any public school in the state.

Q19. Do you support or oppose allowing students to choose any public school in the state, even one in another school district?




Even if they had options, most parents say they would keep their child in his/her present school. This is especially true of private-school parents. Within Dayton, however, more than two-fifths of public-school parents (and 31% of charter parents) would move their child if they could. In 1998, 59% of Dayton Public School parents said they would send their oldest child to a different school if given the support to do so. See (http://www.edexcellence.net/foundation/publication/publication.cfm?id=49) By, 2003, perhaps many parents who wanted choice have availed themselves to it.

Q18. If you could send your oldest child to any school you chose, would you send your child to the school he/she now attends or to a different school?




If they could choose, most Dayton parents would not send their children to DPS high schools. 57% of DPS parents would prefer a private or charter school or high school in another district versus 41% choosing a DPS high school. That is also true of nearly all private and charter-school parents.

As in 2001, Dayton area parents support charter schools. For every one who would stop them, four would keep or expand them. Among DPS parents, the ratio is 1:3.

Q21. Do you believe that charter schools should be expanded, continued as they are now, or be stopped altogether?



Daytonians don't buy the assertion that charter schools sap resources from traditional public schools. Almost two-thirds say that "tax money is for a child's education, no matter what school he attends."



II. School Satisfaction and School Problems

Dayton parents, like other Americans, generally give high marks to their own child's school, but the strength of their satisfaction varies by school type and community, as do the school problems that parents perceive.

Eight in ten Dayton parents give their oldest child's school grades of A or B, compared with seven nationally.

What grade would you give the school that your oldest child attends?





Q2. What grade would you give the school your oldest child attends?




A growing number of Dayton parents see the public schools improving. In 2001, only 12% felt that the Dayton Public Schools had improved in the previous five years while 53.8% felt they had "gotten worse." In 2003, 24 percent of Dayton parents feel the schools have "gotten better;" while 37% think they have "gotten worse." In every sector, parents are generally satisfied with their children's class sizes, though private and charter parents are more likely to be *very* satisfied.









Q5. The extent of parental involvement.






Most would empower individual schools to make more key decisions.

Q15. Allow individual schools to make decisions about what to teach, which teachers to hire, and how to spend their money.




A narrow majority supports holding principals accountable for student results.

Q14. End the jobs of school leaders and principals whose schools repeatedly fail to pass the state achievement tests.





Q13. Dramatically increase the pay of school leaders and principals when their schools pass the state achievement tests.







Q23. Getting promoted to the next grade or graduating from high school should depend, in part, on passing the state tests.





Daytonians give mixed reviews to local, state and national leaders with respect to education reform.


More than 80% of Dayton-area parents feel the principal of their child's school is providing the necessary leadership.

Support for the job being done by local school boards is moderately strong among Dayton public-school parents and very strong among suburban parents. Charter and private-school parents are less contented.


Q27. Do you think the local school board in your community is doing a good job or a poor job of improving public education?


Q34. How much do you think the \$650 million recently approved by voters will help school performance?









Background & Methodology

In June 2003, The Fordham Foundation contracted with Paragon Opinion Research to conduct a phone survey with parents of school-age children living in and around the Dayton Public School District. The study's purpose was to get a snapshot of the views of Dayton-area parents on issues related to education circa 2003. The study contrasts the views of four groups of parents: Dayton public school parents, Dayton charter school parents, Dayton private school parents and Miami Valley parents (parents who have children in Montgomery County public school systems other than the Dayton Public School District).

The questionnaire's focus for the parents was to be upon 1) an evaluation of their child's education and school, and 2) an evaluation of their opinions on the Dayton Public School system, school choice, and a variety of school-related issues. Miami Valley parents were required to participate in all questions with the exception of those directly related to the Dayton Public School District.

Interviewing of parents began on July 8, 2003 and was completed on October 20, 2003. The demographic emphasis of all interviews conducted after October 1, 2003 was on African American parents with children in a public school within the Dayton Public School District. The survey sample was pulled from the total population of parents with school-age children living within the Dayton Public School District and Montgomery County boundaries. Those surveyed included parents with a child attending a public or vocational school, private or parochial school, or charter school. At the 95th% confidence level, had Paragon Opinion Research completed surveys for the entire sample, the results would differ from the results presented below by no more than 2.65% in either direction for the total sample of 1,400 respondents. The populations and sampling errors of each group follow:

Up to three calls were made to each of the telephone numbers available in order to complete an interview. Once the quotas were reached for each of the group types, calls were restricted to parents from school types where quotas were not yet met. The time of the day and the day of the week for callbacks were varied so as to maximize the chances that any given respondent from the sample could participate in the survey. Interviews were also conducted on weekday evenings in order to reach the working population of residents within these areas.

When using a confidence level of 95% as we did throughout this study, the results can be read to mean that statistically each response total could be 5% higher or 5% lower than what is actually stated.

Paragon Opinion Research would like to point out that, while the Caucasian vs. African American percentages may seem out of proportion based on the actual populations of these races within the school district, the sample used for the survey was a *random* sample and every member of the community with school-age children had an equal opportunity of being contacted to participate in the survey. Telephone research has become increasingly difficult in recent years and we find that members of the community with higher than average education and income levels are more likely to participate in surveys, which in most cases includes a higher Caucasian population. These racial breakdowns are almost identical to the results from the 2001 Fordham survey.

The analysis of some questions also includes comparative results pulled from this year's Phi Delta Kappa/Gallup education poll of parents nationwide.

Important to note is the use of abbreviations throughout the report for the various school types:

- DP-Public / Public School within the Dayton Public School District
- DP-Private / Private or Church-Related School within the Dayton Public School District
- DP-Charter / Charter School within the Dayton Public School District
- *MV-Public* / Public school outside the Dayton Public School District (Miami Valley Public School)
- *ALL Types* / The combined responses of respondents from the DP-Public, DP-Private, DP-Charter, and MV-Public Groups
- All DP Types / The combined responses of respondents from the DP-Public, DP-Private, and DP-Charter Groups
